## TERMS OF LIMITED WARRANTY

- WHO CAN ENFORCE THE WARRANTY.** Dealer offers this Limited Warranty to the original Purchaser named above. It cannot be transferred to any other person. Only the original Purchaser, and any person who is entitled under applicable state law, may enforce this Limited Warranty.
- PARTS OF VEHICLE COVERED BY LIMITED WARRANTY.** The following parts are covered by this Limited Warranty, but only if the defect or malfunction in the part is caused by a mechanical breakdown or failure (the inability of any covered part to perform its designed function):

- EXCLUSIONS FROM THIS LIMITED WARRANTY.** Any part(s) or system(s) of the vehicle which is not listed in Section 2 is excluded from coverage under this Limited Warranty. Any malfunction resulting from misuse, negligence, alteration, accident, racing or engaging in a contest of speed or endurance of any type, or any malfunction resulting from failure to perform periodic maintenance in accordance with the manufacturer's recommendations, is excluded from this Limited Warranty.
- PERCENTAGE OF REPAIR COSTS COVERED BY LIMITED WARRANTY, AND DURATION.** For a period of \_\_\_\_\_ DAYS from the date of purchase of the vehicle identified above, or \_\_\_\_\_ MILES beyond the odometer reading stated above, whichever occurs first, Dealer will pay for \_\_\_\_\_% of the total costs of parts and labor necessary for repairs to those part(s) or system(s) covered by this Limited Warranty.
- PURCHASER'S OBLIGATION.** In order to receive service under this Warranty, Purchaser must notify Dealer's service department of any failure, malfunction or defect of any part(s) or system(s) covered. Purchaser must then deliver the vehicle to Dealer's service department within five (5) days of such notice for any warranty work to be done. Purchaser must authorize in writing all repair work to be done before Dealer will do the work. When the repaired vehicle is re-delivered to Purchaser, Purchaser must pay for all expenses (plus applicable sales taxes) for the work done, except those expenses which Dealer is obligated to pay under this Limited Warranty.
- DEALER'S OBLIGATION.** Dealer will start all repairs on the vehicle within 48 hours, excluding weekends and holidays, after delivery of the vehicle to Dealer's service department. Dealer will repair any part(s) or system(s) covered upon written authorization of Purchaser according to dealer's normal service policies and subject to the availability of replacement parts. All expenses for the remedy of defects to or malfunctions of part(s) or system(s) other than those covered by this Limited Warranty shall be paid for by Purchaser.
- LIMITATION OF IMPLIED WARRANTIES.** All implied warranties, including the implied warranties of merchantability and fitness for a particular purpose, are hereby limited to the same duration of time as the express written limited warranty stated herein.
- EXCLUSION OR LIMITATION OF CONSEQUENTIAL DAMAGES.** Purchaser shall not be entitled to recover from dealer any consequential damages, damages to property, damages for loss of use, loss of time, loss of profits, or income, or any other incidental damages.
- PURCHASER'S LEGAL RIGHTS.** Some states do not allow limitations on how long an implied warranty lasts, or do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This Limited Warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

This is a Limited Warranty and it is the only written or express warranty made by Dealer on his own behalf on this vehicle. The statute of limitations applicable to this Limited Warranty is hereby expressly agreed by Dealer and Purchaser to be two (2) years. There are no other express agreements between Purchaser and Dealer.
