2022-2023 CATA BOARD ACTIVITIES

ANNOUNCED the election of J.C. Phelan, Chairman; Kelly Webb Roberts, Vice-Chairman; Jason Roberts, Treasurer; and Ryan Kelly, Secretary.

EXECUTED Board of Directors and Staff Conflict of Interest Statements.

NOTED that Sam Cicinelli has accepted a new position as IAM Midwest Territory Office Special Assistant to the General Vice President and has resigned his position as Directing Business Representative, replaced by Mark Grasseschi.

NOTED that Dave Radelet has assembled a group of dealers to negotiate the Local 731 labor agreement.

ANNOUNCED a media kickoff for BBQ for the Troops to be held on June 22, 2022.

DISCUSSED AND APPROVED maintaining Chicago Auto Show exhibit space cost at \$8.50 per square foot; increasing the cost of indoor track space to \$7.50 per square foot; and charging exhibitors \$30,000 and non-exhibitors \$60,000 for use of the shared EV track.

DISCUSSED AND APPROVED selling food station sponsorships at the First Look for Charity event.

NOTED 229 golfers and 50 additional attendees for lunch attended the 2022 CATA Annual Meeting and Golf Outing at Cog Hill Golf and Country Club; sponsorship revenue amounted to approximately \$90,000.

DISCUSSED AND APPROVED a First Look for Charity Media Tasting event to take place at Goose Island Barrel House on December 6, 2022.

ANNOUNCED seven indoor test tracks and four outdoor test drive opportunities at the 2023 Chicago Auto Show.

APPROVED attendance by Ms. Morand and Mr. Konecki at Electrify Expo, the largest E-Festival in North America, in Austin, Texas.

APPROVED attendance by Ms. Morand and Messrs. Sloan, Konecki, and Bilek at the Los Angeles Auto Show from November 16-18, 2022.

DISCUSSED AND APPROVED the annual audit and Form 990 for CATA and First Look for Charity Foundation for the year ended June 30, 2022.
